Citizens' committee/ Group of organisers

Setting up of a group of minimum 7 organisers residing in 7 different Member States

Registration

Registration of the initiative with the Commission which verifies, inter alia, that the proposal does not fall manifestly outside its competences

Collection

Collection of statements of support in paper form and/or online

Verification

Verification of statements of support by competent national authorities

Examination

Meeting with Commission, public hearing in the Parliament and final response of the Commission

Follow-up actions, if any
